Fund Setup & On Boarding

Set up and on — board LPS and periodically update the fund / AIF details in our fund accounting system based on PPM/Fund documents and other details provided by the Client.

Migration of Data

Migration of data into service provider internal systems.

Transaction Processing

Capture of transactions in the fund accounting system based on bank statements (debits and credits) and clarifications provided by client wherever necessary.

Bookkeeping and Accounting

Maintaining General Ledger, generate Trial Balance, Profit & Loss Account & Balance Sheet along with all schedules, Cash flow statements. Generally accepted accounting practices would be followed.

Reconciliation

Bank statement reconciliation of contribution receipts, income receipts, capital exit and distribution payouts, expenses, and investments made with the fund accounting books at agreed frequency.

Returns Computation

Capability for income and expense allocation at class level / investor level. Computation of Hurdle Rate, IRR computation at Investor Level/ Script Level/ Scheme Level.


